Tray Adhesive (Instructions For Use)

INTENDED USE: Tray Adhesive is indicated for application to impression trays to enhance the adhesion of impression materials to intraoral impression trays including perforated and non-perforated stock metal and plastic, custom acrylic trays.

COMPOSITION: Adhesive compatible with impression materials

PRODUCT DESCRIPTION & PROPERTIES:

MAARC tray adhesive is used to enhance the adhesion of impression materials to stock metal or plastic (solid or perforated) or custom acrylic impression trays. Certain impression materials may get separated from the impression tray upon removal from the mouth leading to distortion errors. Using the Maarc tray adhesive helps in securing the impression firmly to the tray upon removal from the mouth.

PROCEDURE:

- · Select and/or prepare a suitable tray. Prior to application of Maarc Tray Adhesive, trial fit tray for proper fit and extension.
- After proper fit is assured, rinse and thoroughly dry the tray.
- Brush a thin layer of Maarc Tray Adhesive onto the tray surfaces that will be covered with impression material and allow to air dry for at least three minutes, but not more than 10 minutes.
- Repeat application if more than 10 minutes have elapsed after application.
- Avoid placement of excess adhesive onto tray surfaces. Retention is not enhanced and may be compromised by placement
 of a thicker layer of tray adhesive onto tray surfaces.
- Mix and place desired impression material directly into the coated impression tray as per selected impression material directions.
