## PLAQUE - D (Instructions For Use)

#### Intended Use:

Dental plaque disclosing gel.

## Indications:

To identify plaque before oral prophylaxis. Patient education and motivation about oral hygiene.

#### Composition:

Sodium Saccharin, Gelant, Staining agent, Water.

## Product Description & Properties:

Plaque-D is a water based gel contains staining agent. It helps in differentiating plaque by colour and aids in patient oral hygiene education. The gel is easy to apply and provides good control over the flow.

#### Procedure:

- Apply Plaque-D onto the tooth surfaces using a suitable instrument (microbrush, swab or tooth brush).
- 2. After 10 seconds, Instruct the patient to lightly rinse their mouth with water.
- Identify the plaque by observing the color of the gel or stained plaque. A pink colour on the tooth surface indicates plaque accumulation.
- Educate the patient about the accumulated plaque using a mirror or intra-oral camera. Instruct the patient with proper tooth cleaning or oral hygiene practices and remove any remaining plaque and disclosing gel.
- Ask the patient to rinse mouth thoroughly and spit the residues. This product is not intended to be ingested.

## Caution / Warning:

1. Do Not use the product if the patient is allergic to any of the constituents of the device.

- 2. Use caution to prevent the product from coming in contact with the skin or eye.
- If the product comes in contact with skin or eye, take the following actions: Immediately wash the eye with copious amounts of water and consult a physician. On contact with skin immediately wipe it off with a cotton swab moistened with alcohol or gauze and wash with copious amounts of water and soap.
- Avoid direct contact with the skin and / or soft tissue to prevent hypersensitivity.

- 1. Do not mix the product with any other dental materials.
- Do not use the product for any purposes other than those specified in INDICATIONS.
- Do not use on patients having erosive gingivitis, mouth ulcers, any oral injury or any such conditions.
