

#### T-Fill (Instruction For Use) (Temporary Filling Material)

## Product Description of T-FILL

T- Fill is a ready to use temporary filling material (Type II- Temporary Cement for bases and temporary restoration) in paste form, self-curing under humidity, to be used for temporary filling of cavities during restorative or endodontic treatment of teeth.

#### Ingredients:

Zinc Oxide, Barium Sulphate, Zinc Sulphate, Calcium Sulphate, Talc, Vinyl Acetate, Acetate of Ethylene Glycol, Coloring & Flavoring agent

Flavor : Mint

#### Indication of use:

For use as temporary filling material during endodontic and restorative treatment of teeth.

2) For use as Temporary Inlay material

#### Properties

1) Eugenol free offers non irritating properties.

- 2) Higher adhesion to teeth structure.
- 3) Micronised and homogeneously mixed for grain free consistency. Gives best adaptability.
- 4) Quick selling in moist conditions.
- 5) There is minor but even expansion on setting so no cracks develop, giving best sealing Hence protecting to Pulp.

## Applications

Use a cement carrying instrument to fill the required quantity of T-Fill into the prepared cavity after air drying. A ball burnisher can be used to adapt the T-Fill to the margins of the cavity for better marginal seal.

The hardening process starts after few minutes of contact with moisture or patient's saliva. Avoid any exposure to chewing pressure for about 2 hours after application.

Pressure free application is recommended when used in conjuncture with a root canal dressing material.

Inform patient , In case of fracture of the restoration, get restoration repeated as soon as possible.

#### Setting time

Initial setting time : From 9 minutes, once it comes in contact with saliva. Final setting time : 24 hours, once it comes in contact with saliva.

#### Contraindications

Do not use the product if the patient is allergic to any of the ingredients.
Not Intended for Permanent cementation.

#### Product Handling:

Product being moisture sensitive, close jar immediately after dispensing the material, do not use wet Instrument to dispense material. Moisture contamination would change consistency of product and reduce its usability. Product to be used by qualified dental professional or qualified dental assistant.

After opening store in refrigerator (Do not freeze)
