GSOL (Instructions For Use)

Please read carefully before use

INTENDED USE:

GSOL is intended for use during repeated root canal treatments to remove outta-percha cones from the root canal

INDICATIONS:

During re-root canal treatment of teeth.

COMPOSITION

Orange oil (>95%)

PRODUCT DESCRIPTION & PROPERTIES:

It is an orange oil (D-limonene) based Gutta Percha Solvent used for removing gutta percha at the time of Re-root canal treatment.

METHODS OF USE-

- 1. Isolate the teeth using a rubber dam. Prepare the access cavity and apply a few drops of GSOL using a sterile syringe in the root canal from which GP Point is desired to be removed.
- 2. Wait for 2 to 3 minutes for the GP points to soften, use Gates Glidden drills or Peeso Reamers for removal of the softened GP points.
- 3. If the GP is dry or crumbly, re-apply GSOL and remove the GP with the selected root canal instrument.
- 4. In curved canal hand instruments such as H-files can be used for removing the softened GP points.
- 5. Care to be taken not to extrude the GSOL beyond apex.

CAUTION/ WARNING:

- · Do not use it beyond the apex of the canal.
- · Avoid direct exposure to sunlight
- Keep the container closed all the time when not in use.
- Store in a cool and dry area (10°C to 30°C). Improper storage can cause change in properties and may affect the efficiency of GSOL.
- · Once dispensed from the container, do not re-use the device.

PRECAUTIONS:

- Avoid contact with skin, mucosa and eves.
- · Avoid inhalation of fumes.
- · Do not consume or take internally.
- · Contact with the skin/mucosa may cause irritation or hypersensitivity.
